Sample unit - Sample unit consists of employees working at automotive axles. Sample size - 100 responses of automotive axles considered as samples.


Type of sampling - The researcher has considers non probability random sampling Of employees from automotive axles.

From the research it is clear that, 50% are male and 50% of respondents are female.








