As a result, vague set (VSS) are frequently employed in pattern recognition applications suggested by W.L.Gahu, D.J. Buehrer [12] vague sets. These two ideas are complimentary in the sense that by subtracting one from a unit, one can be derived from the other. Definition [1] 2.1: Let $X$ be a non-empty set. A fuzzy set A drawn from $X$ is defined as $A=\left\{x, m_{A}(x): x \in X \quad\right\}$, where $m_{A}(x): X \rightarrow[0,1]$ is the membership function of the fuzzy set A.
Definition[8] 2.2: A vague set $A$ in the universe of discourse $X$ is a pair $A=\left(m_{A}, n_{A}\right)$ where $m_{A}: X \rightarrow[0,1], n_{A}: X \rightarrow[0,1]$ such that $m_{A}(x)+n_{A}(x) \leq 1$ for all $x$ in $X$. Here $m_{A}$ is called the membership function and $f_{A}$ is called nonmembership function and also called truth function, false function respectively.
Definition 2.3 [4] The vague set $A$ of a set $X$ with $t_{A}(x)=0$ and $f_{A}(x)=1$, for all $x \in X$ is called the zero vague set of $X$. It is denoted by $\overline{0}=(0,1)$.
Definition 2.4 [5] The vague set $A$ of a set $X$ with $t_{A}(x)=1$ and $f_{A}(x)=0$, for $x \in$,for all $x \in X$ is called the unit vague set of $X$. It is denoted by $\overline{1}=(1,0)$.
Definition 2.5: Let $A=\left(t_{A}, f_{A}\right), B=\left(t_{B}, f_{B}\right)$ be two vague sets of a set $X$ then their union is defined as $A \cup B=\left(t_{A \cup B}, f_{A \cup B}\right)$ where, $t_{A \cup B}=\max \left\{t_{A}, t_{B}\right\}$ and $f_{A \cup B}=\min \left\{f_{A}, f_{B}\right\}$.

## 3. Vague sets:

The vague set theory has been developed in [3] as a generalization of the ordinary fuzzy set theory [3]. As an extension to the conventional Boolean set theory with its two possible values, true and false, the fuzzy set theory handles values that are partially true - partially false. In classical set theory the membership of an element to a given set is assessed by an indicator function that an be either 0 for non-membership, or 1 for membership. By constructs, in the fuzzy set theory the membership of an element to a given set is caused by a membership function that can take any real value in the interval $[0,1]$.This membership function, denoted by $\mu$ is termed degree of membership. The complement of the membership function to 1 , denoted by $v$, is termed degree of non-membership. Both $t_{A}$ and $f_{A}$ can take real values in the interval $[0,1]$, such that $\left.0 \leq m_{A}(x)+n_{A} x\right) \leq 1$. In the classical set theory either $\mathrm{m}_{\mathrm{A}}{ }^{(\mathrm{x})}=1$ and $\mathrm{n}_{\mathrm{A}}{ }^{(\mathrm{x})}=0$, or $\mathrm{m}_{\mathrm{A}}{ }^{(\mathrm{x})}=0$ and $\mathrm{n}_{\mathrm{A}}(\mathrm{x})=1$. The vague set theory further generalizes the ordinary fuzzy set theory by allowing the degrees of membership and non-membership not necessarily add up to 1 , so that $0 \leq \mathrm{m}_{\mathrm{A}}{ }^{(\mathrm{x})}+$ $\mathrm{n}_{\mathrm{A}}{ }^{(\mathrm{x})} \leq 1$. The c omplement of the sum of the degrees of membership and nonmembership to 1 , denoted by $\pi$, is termed degree of uncertainty about membership or non-membership. All the three degrees $\mathrm{m}_{\mathrm{A}}{ }^{(\mathrm{x})}, \mathrm{n}_{\mathrm{A}}{ }^{(\mathrm{x})}$ and $\pi$, can take real values in the interval $[0,1]$, such that $m_{A}(x)+n(x)+\pi=1$. In the ordinary fuzzy set theory $\pi=0$.
