2. Case summary: A 50 year old man presented with Disturbance in thinking, confusion, forgetful, harming others, hears unnecessary noise, and difficultly in speech according to the totality of symptoms the case was evaluated and on the basis of individualization Similimum medicine was selected and outcome of the treatment was analyzed using Brief psychiatric rating scale. The aim of the article is to demonstrate the effectiveness of homeopathy on schizophrenia.

INTRODUCTION

Schizophrenia is a chronic psychiatric disorder with a heterogeneous genetic and neurobiological background that influences early development and is expressed as a combination of psychotic symptoms such as hallucinations, delusions and disorganization and motivational and cognitive dysfunctions⁽¹⁾. The most important psychopathological phenomena is thought echo⁽²⁾. The Schizophrenia is divided into four types they are catatonic, paranoid, hebephrenic and simple schizophrenia. The exact cause of schizophrenia is not known. But like cancer and Diabetes mellitus schizophrenia is a real illness with a biological basis. Yet researchers are cautiously optimistic that we will soon have some answers regarding the etiology of this disease⁽³⁾. The peak age of onset of schizophrenia are 10-20 years for men, 25-25 Years for women. In India the Schizophrenia is more common in men. The world health organizations global burden of disease estimates of 2011 indicates that schizophrenia is the 17th leading cause of years lived with disability as compared to being 19th in the year 2000. According to the WHO mental health gap Action program in India the prevalence rate is 200 per cases 100,000 people for observational schizophrenia. In an conducted by CCRH from 1984-2005 at CRI (H) Kottayam, Kerala India on 4179 patients with different types of behavior disorder It was found that 785 were schizophrenic. The peak In India the Schizophrenia is more common in men⁽⁴⁾. The pathological changes are noted in the frontal lobe, hippocampus and basal ganglia, dopamine hypothesis it is hypothesized that Schizophrenia is the result of dopaminergic hyperactivity in the CNS especially D-2 receptor⁽⁵⁾. Schizophrenia has varied symptoms that begin in early childhood usually continue throughout life. Most patients have a history of behavioral dysfunction primarily social and learning difficulties⁽⁶⁾. The important symptoms are Disturbance in thinking, delusions, motor disturbances, Disturbance of perception, Schizophrenia cognitive disturbances. diagnosed on the basis of clinical features. Psychometric test may helpful. Schizophrenia possesses the threat of chronic handicap and the treatment should be instituted therefore earlier⁽⁷⁾.

Homeopathic literature enlist many medicine for schizophrenia such as *Belladonna*, *Sulphur*, *Nux Vomica*, *Hyoscyamus Niger*, *Stramonium*, *Phosphorus*, *Aurum Metallicum*. (8)(9) Studies revealed the satisfactory role of homeopathy in managing the schizophrenia but no studies relating to the effect of homeopathy in

Schizophrenia treated with *Arnica Montana* has been published yet.

A case report on schizophrenia was successfully treated with homeopathic medicine *Arnica Montana* is presented here. This case highlights the effectiveness of homeopathy for treatment of schizophrenia following the basic principles of homeopathy.

MATERIALS AND METHODS

Case Presentation

A 50 year old lean, thin man reported in the outpatient department (OPD) on 23,November 2022, with a complaint of disturbance in thinking, confusion, forgetful that appeared gradually he also complained of harming others, hears unnecessary noise and difficulty in speech. since 1 month, patient was a known case of Schizophrenia with a history of psychic features in the past one month for which he underwent treatment in allopathy but he was not relieved so his bystanders eventually opted for homeopathy treatment. The patient did not suffer from any other major illness in the past. Family history was not significant.

The patient was very well behaved during his childhood, he was average in studies, he was depressed due to his work, due to that he will become anger and nervous, he feels irritable even though he is sick he will say "I am not sick", he is very forgetful in words while speaking he is indifferent in his work always lazy, he always want to be alone due to fear of others will approach him, he had disturbance in thinking, confusion about what to do. He will harm others by fighting with others, he hears unnecessary noise such as someone one is calling him, his speech is difficulty. He was married at the age of 25, he had 2 children, his relationship with his wife is good except when he become anxious.

Physical generals

Patient had a thermal reaction towards hot, He baths thrice daily in cold water, during winter season, His appetite was good and he desires hot food, but he had aversion to milk, His tongue is white coated moist tongue, He had moderate thirst, Stool is regular he had to go 1 or 2 times a day, Urine is involuntary during night at bed. He

perspire moderately, Sleep was normal 6-8 hrs sleep per day. No specific dreams mentioned.



After Repertorisation *Arnica Montana* has scored highest marks 10/24 followed by *Nux Vomica* scored 8/15 and *Natrum Muriaticum* and *Pulsatilla Nigricans* scored 7/17 but considering

the analysis and evaluation of symptoms of the case and consulting the Materia Medica, *Arnica Montana* (12)(13)(14)(15) was selected, patient was followed up as per need, potency selection and repetition of dose was done as per Homeopathic philosophy (16)(17)(18)

PRESCRIPTION: Arnica Montana 200C

Selection of medicine and potency: After considering Repertorial totality and due consultation with Materia Medica *Arnica Montana 200* was selected . The dose was selected according to the susceptibility of the patient.

Various studies proved that the Arnica Montana can able to cure the mechanical injury, open wounds, contusion, Over years physician also use it as a powerful weapon to cure any injury, but in this case the patient presented the most peculiar symptom of Arnica Montana as "I am not sick" and other features such as Confusion, forgetful, anger, fear, involuntary urination based on the totality of symptoms similimum medicine is selected after repertorization and with due consultation of materia Medica and outcome of the treatment is analyzed using Brief psychiatric rating scale .. This case is not an evidence based on previous study. The outcome of this study is to prove the role of Arnica Montana in schizophrenia.

It is concluded that that positive response and gentle restoration of health within the specific time is possible only by the similimum medicine thus totality of symptoms is the sole guide to the successful recovery of the patient.

CONCLUSION:
