ABSTRACT

Religion is simply an accepted pattern of behavior showing gratitude, an integrated system of expression and the spiritual or emotional attitude towards the God. Since the human civilization had developed in different social groups under different regions, different religion came into existence with some distinct practices or better to say with distinct strategies as developed by the concerned social groups. These all strategies were developed in the name of oral and written commands of God and later on converted into 'Holy Books.' Nothing wrong was there until different social groups interacted with others and tried to establish the superiority of one's own belief over the others. Since the interactions were and even is inevitable, so is with religious conflicts. These conflicts have remained a root cause of many social tensions but no effort has been made to use distinct religious principles, relatively, to establish social cohesion and peace in the society except by saying that God is one. If we debate on these religious conflicts and try to find out the root cause of this conflict multiple reasons may be recorded but, as per the opinion of authors, 'misinterpretation' of Holy Scriptures, patterns of behavior, expressions and spiritual or emotional attitude of different 'belief' groups is the only one. Hence under this literary work, the authors have tried to explain that reasonable and contemporary interpretation of all religious scriptures, religious practices etc. would certainly end the conflicts and would promote brotherhood, harmony and solutions of many known and unknown issues whereas misinterpretation of religious scriptures would certainly end humanity and society if not controlled within the stipulated boundaries.

INTRODUCTION: "In a world where various forms of modern tyranny seek to suppress religious freedom or try to reduce it to a subculture without right to a voice in the public square or to use religion as a pretext for hatred and brutality, it is imperative that the followers of the various religions join their voices in calling for peace, tolerance, and respect for the dignity and rights of others."

Religion means faith in a supernatural power which is far more superior than human beings. But since past decade it has witnessed a sharp increase in the violent religious tensions. It starts from Islamic extremists waging for Jihad at a global level and the struggle for power between Shias Sunnis to the persecution of Myanmar and Simultaneously an outbreak of violence among Muslims and Christians at South Africa. Today the spike in religious conflict is not only at National level but globally. Religion is not a phenomena of recent emergence. Itsbeginning is unknown. Some of the boreal practices of Indian man indicate that human being was a religious creature long before history began. Institution of religion is universal it is found in all the societies past and present. Laws customs conventions fashions, religion are not only the means of social control butit is all our religion and morality which formulate and shapes all of them. They are not only the most influential forces of social control but also the most effective guides of human behavior. The social life of man in addition to its economic political philosophical, scientific and other aspects has also one aspect that is the religious aspect. Religion has been in existence from the beginning but also it has been exerting a tremendous influence upon the institutions. Religious dogmas have influenced economic and political movements' property dealings educational tasks ideological approaches etc. Religion which is based on the cultural needs of man has added new dimensions to human life and human development. Religion revolves around mans faith in the supernatural forces. It is the concrete experience which is associated with emotions especially with fear or irreverence many societies have a wide range of institutions connected with religion and a body of special officials with forms of worship ceremonies, sacred objects, titles images and the like. In modern civilization it is religious leaders who have developed various theories to explain man's place in the universe for religion is closely associated with morality and has elaborate rules of conduct for the world religions. Hinduism Buddhism, Christianity and Islam are really sentence of elaborate cultural systems that have

dominated all societies for centuries. It tries to throw light on the fact that how sacred or pure things came into being, showcases the evolution of such concepts, their historical background, the creatures inhabiting it and present concerns. It provides valuable information regarding universe, about the creation of life, the end of the world etc.It gives us the idea of empirical world. It tries to establish the relationship between empirical world and sacred things. In both of theses cases belief rests upon faith of the people and their perspectives rather than on observation. Universal acceptance of religion shows that religion has a great survival value.

OBJECTIVES OF THE PAPER:

- 1. To instill logical psychological tendencies in the minds of the youth that the religious teachings of all the institutions are one and the same.
- 2. To promote solidarity and unity in society through revival of culture in religious context that has forgotten long back by people.
- 3. To highlight obscurantist and fundamentalist approach in the name of religion exaggerating hatred and crime in society.
- 4. To explore the fact that how religious texts has been misinterpreted by the Priests and Maaulvis for the fulfillment of their own vested and selfish ends.

RESEARCH METHODOLOGY USED: To substantiate the key arguments presented in the aforementioned section, the present study invokes a case study research approach. In simple terms, a case study covers the entire gamut of a particular phenomenon by covering all its aspects such that the unit/s of analysis is probed at length (Yin, 2013). Whereas the present study conceptualizes a historical period, the lessons derived there from constitute an intrinsic dimension for understanding the present-day fundamentalist approach in religion. To put it clearly, the present study refers to the Shlokas of Rig Veda and Teachings of Quran, Bible and Guru Grantha Sahib as a base to understand how logic and rationality of a religion surpassed the meek arguments of fundamentalists when the societal fabric is tossed in favor of giving a political color to religion.

UNIVERSAL PRINCIPLES OF RELIGION:

The universality of religion is not based upon the forms of belief and practice but upon the social functions which religion universally fulfills. Religion provides a religious experience it provides peace of mind. It provides for the individual the most desired peace of mind, at every crisis we look for harmony and mental peace. Religion molds the

personality of the people in a proper direction and exaggerates morality among them. In an uncertain world, full of dangers, the very challenges of every single day there is a die need of protection and security. Religion eradicates all the negativity of life. It minimizes the genuine grievances of the people to a considerable extent. Religion showers an emotional and moral support in this uncertain world and helps in accommodating the complex situations of life. It helps in reconciliation whenever people in stressful situations which is a gift of norms and value system of society. At the same time, it is the religion which offers inspiration, hope, optimism and courage. Relation is also expected to promote social solidarity in society apart from unity and identity. It is because religion upholds and validates the traditional ways of life more than it unites the people it is known that the common faith common value judgments, common sentiments, and common worship are significant factors in underlying people. By their participation in religious rituals and worship people try to identify themselves as having something in common. According to Davis religion provides recognition, identity with the past and the limitless future. A.W. Green has pointed out religion is supremely integrating and unifying force in human society. Religion conserve the value of life relation; it is an effective means of preserving the values of life. It defines and redefines the values morals spiritual and social values which are greatly supported by religion.. But unfortunately in present scenario religion has been held responsible for promoting violence conflicts in society. It is a wellknown fact that the religious scriptures of every religion be it Hinduism, Islam, Buddhism, or Christianity speaks something good but sometimes bad, or absurd It is often said that theses scriptures are the statements of God. But can we trust that they are not written or manipulated by man? It may be possible that some clever people wrote them and spread them in the name of God. What should be done, even if they are voice of God should we accept them if they are opposed to logistic and reason. Those who believe that whatever is written in religious text is up to the mark are so much fanatic about it that they do not tolerate any deviation from its norms which is mentioned in the religious text books or scriptures irrespective of the that these religious scriptures misinterpreted and drafted by religious leaders to spread false ideas. They are of the opinion that the entire truth is vested in their own religion. They think that what is not mentioned in their religious texts is not true. It is for this reason that they cannot develop the tolerance attitude towards the other religions, they believe that other religions are false and only their religion is idealistic while others are barbaric. It is because of this that they want to crush them. They fail to understand what is mentioned in all religions is extremely true and all have common teachings and preaching's towards humanity.

The task of the religious texts should be to help a human being in eradicating false sense of ego. To live happily there is a need to understand these texts in an ultimate way. Once human being is able to understand its sublime essence the confirming action will be in the interest of humanity. However there may be certain things in the religious texts which does not go with modern society but with wise wisdom and complete knowledge we can never deviate from our customary track but unfortunately toady neither these religious texts are interpreted in a proper way nor people understand why religious texts are being misinterpreted.

VEDAS AND RELIGIOUS UNITY: There is a false belief that Hindu scriptures promote caste system in society. However, the fact remains is that the foundation of mankind in society is in the form of one of the priced possessions i.e. Vedas. It is the Vedas which treat every human being with equal respect and dignity. (KRINVANTO VISHVAMARYAN) which states nobility of humanity and opposes birth based caste system. With respect to caste system, Guru Madhwacharya clearly stated that, It's your attitude, it's your aptitude, it's your deed and it's your actions which decide your caste. If you are engaged in business you a Vaishya, if you are a monk you a Brahmin irrespective of your birth 'if you are in military you are a Kshatriya. If you are doing nothing in society, you are a shudra. Even the creation of caste and outcaste is unnatural, superficial, and unspiritual. An ancient version points out that Brahmin and blood brothers. outcaste are (Hindu Dharma: General, 2022)

According to 10-13-1 of the Mantra of Rig Veda the entire humanity are the children of divine (SHRUNVANTU VISHVE **AMRUTSYA** PUTRAHA).Mantra 5-60-5 of the Rig Veda addresses that all men are brothers; no one is big or All are equal. Mantra Yajurvedaspecifiesthatall men are brothers; no one is superior or inferior. It reiterates that all men are brothers; no one is superior and no one is subordinate. Mantra 10-191-2 of the Rig veda addresses that," humanity needs to be united to have a common mind and common speech. Mantra 3-30-1 I Atharveda addresses that all human beings needs to be affectionate, love each other in the same manner as the cow loves the calf. Mantra 3-30-6 of Atharveda commands mankind to lunch and dine together and to be firmly united as the spokes attached to the hub of a chariot wheel. The Upanishads and Bhagwat Geetaecho many such Vedic doctrines of humanity and oneness. One of the shlokas of BhagwatGeeta states;

ACTUAL INTERPRETATION OF RAM **RAJYA:** The actual meaning of Ram Rajya does not means Kingdom of Ram rather it indicates, 'Kingdom of God". For Ram and Rahim are not separate deities rather one same God meant for justice and truthfulness. It ensures equal rights whether to a Prince or a Pauper. It includes respect towards all religions. Mahatma Gandhi stated that Praying to God for our own protection is a sin until we aim at protecting the weak. This is supposed to be the Swadharma of all human beings irrespective of diverse religious backgrounds. Chanakya in Arthashastra stated that, the pleasure and happiness of a ruler lies in the happiness of subjects. What matters is what the people like rather than what the king likes". It reflects sovereignty of the people which is based upon pure moral authority.

Almost all the religions of the world have some of the universal features accepted by man. For example the Prophet preaches the message of God which has been granted to him graciously by God. The holy book Quran is considered as the exact record of prophets preaching. It was further maintained by his disciples for theory own purpose and later on for the benefit of posterity. In the same way with respect to priests it is well said that, that they gone through the religious text books thoroughly and succeed in attaining the intuitive wisdom to crack the hard cover of ambiguity in order to get under the roots of underlying truth in the words of holy book. They consider themselves as the harbingers of reformation in society and

religious diversities. Because of religious misinterpretation society is becoming stagnant. The main aim of most of the fundamentalist religious leaders is to advocate for conserving the religious principles and always build a resistant to ne reforms or to new ideas. The scientific approach has a tendency to question and question again and again in order to find out the ultimate truth.

Since time immemorial religious leaders try to gain the trust of the masses in order to have political gains but also to mislead the people. In 16th century the Greek pope misused the faith of the people by selling the indulgence and motivating the people for crusade. In the same in 19th century Bahahullah was put behind the bars for lifetime in Israel as he aimed to bring about reformation in Islam. Today we observe violence in religious institutions because of these religious misinterpretations. It is because of this approach and attitude that there is a resistance to new principles, new ideologies and new thoughts. The situation is further triggered by the fundamentalism approach of religious leaders which causes far more damage to human lives and human societies. It has become a major challenge for the development of the society. Every religion consists of educated class of people who can better interpret the meaning of religious texts in a well defined manner relatively to that of religious leaders but it is very unfortunate that their voices are not audible to the people as they are suppressed by the powerful fundamentalist leaders who dominate the roots of the minds of people. Saints and Priests want everyone to believe that their religious text is the absolute and the final verdict and statement given by God. If things are not mentioned in the religious scripture which they read it's all false according to them. There are very prominent religious scholars who have raised a question mark on the incomplete knowledge of most of the saints, priests and maulvis.

Be it priests or saints all read religious texts or religious scriptures to stir up arguments and to bring about controversies in society.

It is those religious maulvis or priests who lacks spiritual knowledge and wisdom and only sings religious songs. A Mullah who is hungry turns his home into a mosque

In yet another statement, it is stated that if a person wants spiritual hollowness or emptiness from inside one should have friendships with a Sheikh. What actually helps is soul connecting with soul rather than reading religious books and scriptures. (SufiJallaludin Rumi).

Religious scriptures means an instrument of knowledge.. Hence religious scriptures are the instruments of knowledge empowered to mankind for self realization or attainment of the knowledge of the self(Aatm-Gyaan). Thus this true knowledge can help a man to understand the reality- the actualization of one's true nature as Pure Consciousness. It is for this reason that Gurbani holds the perspective that there must be a true understanding, realization and comprehension of religious texts (DHARMAWIKI, 2018). In Suggs 148 it is mentioned that it is by understanding the religious scriptures that mystery of life can be easily understood.

The objective of religious texts is to reveal the path of righteousness to mankind suffering in bondage. The religious texts teach a man how the demands and desires of senses are reconciled by following right path part of every human being and hence one should love all religions. . Man be remind himself that above all man is a human being who should follow the path of righteousness but it is very unfortunate that these religious texts misinterpreted by the Saints, Priests and Maulvis. Divinity is a In present scenario misunderstood in the name of religion which breeds chaos, disorder, conflicts riots, tensions, strains, extremism, blind fanaticism, fundamentalism, religious intolerance , bigotry and a host of many problems in society which have resulted in bloody tragedies and wards in the name of religion. These misunderstandings are result of our lack of adequate knowledge and lack of actual understanding. Today man remembers everything excluding humanity or humanitarian values. The moral values, civic virtues which we learnt in traditional societies are all missing today. We do possess knowledge but it is impartial, incomplete and it is a well known proverb that a little knowledge is a dangerous thing. We lack wisdom, reality, truth, faith, love devotion, spirituality, inward purity, mental stability and steadiness, inner peace, integrity, kindness, hospitality, generosity, self control, self discipline, forgiveness, compassion, patience, fortitude, pride, sympathy, attachment, determination, vigor, introspection, renunciation from inside, noble values, correct information, charity, freedom from greed, desires internal thieves etc. We need to find our own faults and analyze and find faults within inside rather than every time blaming on others.

HUMAN LANGUAGE&RELIGION: Since the gist or theme of all religious scriptures focuses around Transcendental Truth, the truth which is eternal, which is infinite beyond the purview of human mind, body, intellect. Hence, neither the phrases, nor the words can completely express the depth, reality, perspectives and report on the perfect and the infinite and complete reality. Limited number of words expresses limited number of truths. The men of wisdom is of the opinion the

language must be such that it can express four types of thoughts, (Padarth or Vastu), (Gunas or qualities), the activities (Kriya) and the relationships among the finite objects of the Universe (Sambandh). Theses four important aspects of language can constitute this entire world of infinite things.

MISINTERPRETATION OF ISLAM: Today people are being killed due to religious fanatics and people are indulged in wars in the name of religion. Maulvis and Ulemas which is the name given to Muslim religious scholars through believed to have extra ordinary knowledge regarding religion and religious texts who completes their education in Madarsas or DarulUloom. They are being considered as the representatives of God, hence a major responsibility vests on to their shoulders to impart religious education in a well defined manner so that the same may not be misunderstood by the people. But it's very unfortunate that we are observing the opposite of it in present scenario. They are posing a big threats to the Muslims for they interpret the Holy Text Quran in their own ways or the ways that suits them and hardly mention the remaining text to their advisees and completely manipulates their mind in the very initial stages of their life when they are not in a position to distinguish what is right and what is wrong. Their controversial statements can be observed through social media, print media, news channel which are the open platforms to judge the mindset of the Muslims and hence given the names of terrorists.

One of the most prominent religious scholars named as, ZakirNaik has out rightly appreciated Bin Laden for his statement on What Laden did by stating that," If Osama Bin Laden is squabbling for Islam I am the one who is with him. And if he is terrorizing America, I am with him". People who are born in Islam religion ought to be terrorist. But the ground level fact remains that Islam teaches peace, it is a religion of peace and these statements just instigates the people to develop an intolerant attitude among the Muslims. The discrimination promoted by religious leaders is creating societal issues and problems and encouraging a situation of relation crisis among other states. ZakiirNaik gave this very controversial statement in front of the media because of which he was banned. Though he is banned to control the damaged situation but unfortunately his followers are doing the same task of spreading hatred in the minds of people by misinterpreting other religious texts. consequences of giving birth to multiple religious sects in Islam have resulted in bitter consequences not only for the people but for the society too. Consequently, there are many religious beliefs and sects in one religion Islam which makes it difficult to the people to understand to which school of thought they need to practice and to which they need to leave behind.

From a Sociological point of view, none is by birth a criminal so as the case with terrorists too. None of the person is by birth a terrorist or extremist rather it is the social situation or circumstances or primary groups which persuades the people for same. It is observed that the preaching of Maulvis is biased especially when it comes to other religions and cultures. Such Maulvis do not measure the standards of religion, for they do not work in the interest of their own religion Islam rather for their own individual and vested interests. These vested interests begin from having too many followers who could work for them and perform many rituals in order to gather and store more and more money. The name given to such people are not protectors rather destroyers of religion. A person who is not good and worthy of humanity and hides himself under religion and spreads the same virus in society must be totally discarded. It is because of such misinterpretations that are Taliban is born which is actually a fundamentalist political movement which started in Afghanistan and aimed to promote jihad. These Talibanis receive training in Afghanistan to kill people. These people went to the extreme level of extremist approach they started killing people in the name of Isalm and believe that the reward of the same be given in paradise when they will sacrifice their life on this earth. The reason behind this brutality is that they are not genuinely taught the preaching's of Islam which condemns mercilessly killing of innocent people. Neither it is the Islam which teaches the people to kill the others those who do not practice Islam or deny practicing it. Another incident which proved this fact was which took place on September 11, a series of planned attacks by the terrorist group Al – Queda on US. The result of this attack was 2996 people lost their lives while 6000 were severely injured. Equally a huge amount of infrastructure was also devastated. This incident affected globally as the destruction not only ended here but simultaneously the destruction of World Trade Centre adversely affected the economies too.

It is this dysfunctional role of Maulvis and saints which is again creating differences in the minds of people. They manipulate the minds of the youth and try to paint their souls with falsehoods and fallacious thoughts in the name of religion. Though literature may have a different perspective that why people terrorists but it is somewhere the false preaching's of Islam which drives the people

towards terrorism and extremism in the name of religion.

A deep analysis of this situation reveals the fact that there is a close relationship between Talibanis and Mothersas for these were trained and educated at Madarsasa of their area. It is the need of the hour that the government needs to keep a stern eye on the working of these Madarsas and visit these Madarsasa at every Holy place for the sake of humanity. This social problem today is a matter of concern for the maximum nothing of sociologists. As a result of this religious misinterpretation people are fighting with each other in the name of Holy War. Taliban is in Afghanistan having imposed Sharia Law, a part of Islamic Law on the basis of which different aspects of the life of Muslims is regulated.

In an interview conducted in Lahore on 20th October 2012, Chief Justice Iftekar Ahmed not only agreed to the point that of religious misinterpretation but also stated 'Fragmentation of religion without understanding the exact philosophy and actual spirit behind the same has given birth to extremism, fundamentalism and terrorism adversely affecting global peace and harmony. It has resulted in communal violence, wars and bloodsheds in the name of religion in society. The question emerges here is that why Islam is being misunderstood or is it really a religion which produces terrorists in society? Is there an answer to this question? Perhaps yes, there is a need to instill new psychological tendencies in the minds of people so that the reasons behind their abrupt behavior could be understood. And misinterpretation in the name of Islam may be eradicated from the minds of people and an approach focusing on actual religious texts must be inculcated before another solution is formulated. War is the last option in Islam, it is only justifiable in extreme conditions and at the same time has certain limitations. Ouran states that, Fight in the cause of God who fight against you, but one should not transgress the limits. God has no love for transgressors."

JIHAD MISINTERPTRETATION: Jihad actually means a holy war against the evil in you and society. It means if someone is suffering from any negative power one must get rid of it or one must get rid of misfortune. For example, if a person suffers from economic crisis and if he works hard for the same this effort is known as jihad, Even in Arabic there are words to express this gesture of humanity. However there is a difference in between the word jihad and struggle. The word struggle does not reflect any sort of worship in religious sense of word. But when this term became a crucial

part of Islamic terminology, the sense of worship became associated with it, which means if struggle means struggle in simple sense jihad means a struggle for worship which results in giving reward to a given. Unfortunately this term Jihad has been highly misinterpreted by American media, lot many Muslims, as well as in some of the verses of Quran which gave birth to Islam phobia. At present the word Jihad has been closely associated with terrorism and merciless killing of people. This negative interpretation of this term is destroying the harmony of society.

According to orthodox Islam, women do not have souls which is erroneous and contradicts with Ouran(4: 124.It is because of these reasons that religious conflict is caused by religious intolerance against other religious beliefs and practices. Today we observe intractable inter religious wars in between different Muslims and Jews in Palestine, Muslims and Hindus in South Asia and in many other places. Throughout 1950s- 1996 out of the total 47% 33% of the conflicts are religious conflicts. However the fact is that people do not understand the true essence of their religious spirit. The situation gets worsen when these texts are further misinterpreted by the religious leaders. It is all about proving which religion is inferior and which one is superior. Some of these conflict mentioned in Indian history are

Palestine and Israel Conflict: The root cause behind this conflict can be traced out long back in the migration of Jewish people to Israel. Both Muslims and Jews regard Jerusalem as their native and holyl and and thus both the countries aimed to occupy it.

In the same way Hindu Muslim conflict. Hindu-Muslim atrocities are closely associated with Babri mosques and Ram Mandir. Reprisals are one of the most prominent reasons which exacerbate violence among Hindusand Muslims. It was systematic incitement of hatred and jealousy which was instigated by the religious leaders of both the communities which exaggerated the situation further.

FINDINGS & ANALYSIS: The faith of the people is misused and misguided by the religious leaders. It is not confined to one particular religion rather applicable to all. On the basis of the study conducted through various religious texts and viewpoints of religious leaders it is clearly understood that it is both fundamentalism and obscurantist leaders of different sects and religions who are causing more damage and harm to society. In the name of God not only a fatalistic outlook is being promoted but prejudice and hatred is trying to be evoked in the mind sets of people. There is a

difference in what is exactly mentioned in the holy books and how things are misinterpreted by religious leaders to common people.
