Hence his birth was rejoicing event for Tilak family as there had been three daughters before Lokmanya Bal Gangadhar Tilak. His mother, Parvti bai, was an intensely religious woman and worshipped the sun, so that might be she blessed with a son.

Lokmanya Bal Gangadhar Tilak's family

Lokmanya Bal Gangadhar Tilak's family was the Chitpavan Brahmin and mainly known for exceptional intellectual abilities and administrative qualities. Lokmanya Bal Gangadhar Tilak's family was originally from Chikhalgaon resided in Dapoli district in the Konkan region of Maharashtra.

At that time, the Tilak family was involved genuinely in the collection of octroi in Chikhalgaon. Lokmanya Bal Gangadhar Tilak's grandfather, Ramchandrapant, was a storekeeper of the Nanasaheb Peshwa before the struggles of 1857. While Gangadharpant was popularly known for his eminent learning's and knowledge of Sanskrit, and people used to call him Gangadhar Shastri. He was headmaster of a primary school, and in the later phase, he earned the position of Assistant Deputy Educational Inspector.

In 1866, when Lokmanya Bal Gangadhar Tilak was nine years old, at that time, his mother died. Six years later from the death of mother, he lost his father too. Lokmanya Bal Gangadhar Tilak continued 'BaJ' name in the later life as perpetuate mother's his memory. In 1886. Gangadharpant shifted to Poona after the death of his wife. Then he wrote about two books, and among them, he wrote one on trigonometry and other on Marathi grammar.

All the points given above explains that Tilak family was known to be hardy, practical, and industrious. Also, they liked to live their lives in a simple manner, and they were frugal in their habits. Both of his mother and father were the inspiration behind Lokmanya Bal Gangadhar Tilak's religious as well as educational upbringing.

In 1871, when Lokmanya Bal Gangadhar Tilak was at the age of 15, he married to

Tapibai 11-year-old girl from the Bal family of Ladghar Tapibai's was renamed as Satyabhamabai after marriage. Her family was from the Konkan, and they were known for their hospitality and charitable deposition. At the time of Lokmanya Bal Gangadhar Tilak's marriage with Tapi (Satyabhama) Tilak's father trusted Lokmanya Bal Gangadhar Tilak's brother-in-law so much that atthe time of his death.

punished and refused to accept the punishment and walked home with books and slate.

When he was in Poona High School, Sanskrit Shastri dictated the translation of a few Sanskrit verses to Lokmanya Bal Gangadhar Tilak's class. At that time, he refused to take it down, and then at the age of 12, he wrote the word in three different ways. His teacher denied accepting all the translations, then he complained to the headmaster and got full credit for it.

Lokmanya Bal Gangadhar Tilak had honoured the place in Indian history as the maker of modern India.
